



Another clarification was sought that, what information of the citizen will be required in the system?	The forum was apprised that it shall include the basic citizen information etc. These option are required only to pull off the dual entries of the citizens.
How many godowns are currently available with Food Department which needs to be digitalized?	The committee clarified that approximately 23 godowns are available with Food Department which shall be digitalized. Number of godowns can be vary with time.
Is integrated payment platform available with PE or the consultant will have to develop it?	The forum clarified that the integrated payment platform is available with KPITB which is used by Excise and Taxation Department which can be utilized for the said platform however incase PE opt for another option then the PE may go for the financial institution (Easy Paisa, Jazz Cash etc) for payment gateway. In this specific case the consultant is not required to design any payment platform. Any payment gateway



06	Public facing portal will be developed by the consultant from scratch?	Yes, the consultant shall be required to develop a public facing portal.
07	Where will the data be hosted and what are the primary and secondary sites?	The forum clarified that the data will be hosted in the KP Data Center having its primary site in Peshawar and secondary site in DI Khan. The consultant will be responsible to Configure and Deploy Software System at Data Center server allocated for the Disaster recovery mechanism/setting.
08	Can the data be hosted on public cloud?	No, the data cannot be hosted on the public cloud.
09	How many users will be required for Financial Management Information System Module?	The committee clarified that the financial management system is required for Food Safety & Halal Food Authority and approximately 35 users will be required however it shall not be restricted to the specific number of users.
10	What is the approximate number of users to be handled by the HRMIS & which sub modules are required in the HRMIS?	Approximately 500 users will be required in the HRMIS, and the expected submodules shall include but not limited to payroll management system, leave management system, transfer posting management system, performance appraisal module etc. It shall also be accordingly integrated with FMIS however it shall not be restricted to the specific number of users.
11	Shall the bidder include the licensing cost associated with the development of the subject platform, or the PE will borne that cost?	The consultant shall include the cost of licensing associated with the development of the subject platform. The PE will not bear any such out of pocket expenses.
12	Does the consultancy include the cost of Hardware?	The consultant is not required to add the cost of hardware as the PE will procure the hardware separately. The consultant will only be required to propose the specifications of hardware if any required.
13	What are the activities involved in the lab management system? Clarification is required.	The forum apprised that the rationale behind the lab management system is to minimize the involvement of the human interaction in the labs of Food Safety & Halal Food


