- h). Not have had your business activities suspended or debarred from public procurement by the Office of Government Public Contracts Policy;
- i). Be eligible, as defined below;
- 6. Documents Evidencing Eligibility: You are requested to submit copies of the following documents as evidence of your eligibility.
 - a). Valid trading licence or equivalent;
 - b). Valid certificate of registration or equivalent;
 - c). Valid registration certificate with FBR and proof of active tax payer
 - d). Affidavit of non-blacklisting/non-bankrupt
 - e). Proof of 03 similar projects completed (POs/contracts)
 - f). Detail description/broachers of the product offered
- 7. Origin of Goods: All Goods and related services shall have as their country of origin an eligible country.
- **8. Technical Criteria:** The Specification details the minimum specification of the Goods required. The Goods offered must meet this specification.
- 9. Currency: Quotations must be priced in Pakistani rupees.
